Who is buying on the internet?

- Greater in Europe than in Latin America (third largest buyer, after the United States and New Zealand)
- Domestic and intercontinental buying and selling
- Difficulty of accessing platforms reduces early-age users
- Buyers: Mostly recreational users
- GDS: 9.3% buy drugs in the deep web;
- More likely to be men, educated and less likely to be a regular clubber
- In Latin America, facebook is more commonly used.



What is being bought on the internet?

- Cannabis is the most purchased substance by quantity
- MDMA is the most purchased substance by value
- "Conflict-free cocaine"
- Cocaine costs 40% more
- 90% of shipments arrive
- Markets last a short time
- Reflects the off-line market. What do users actually want?
 5 categories...



How is the quality on the internet?

- Cocaine samples were purer and less likely to be adulterated than other sources
- Of the 200 samples, 91.3% coincided with the expected substance (Drug analysis in Spain: 48% - 2014)
- Compared with 41-43% MDMA and 60% LSD during analysis at parties.
- Relationships based on trust between sellers and consumers, reviews, user comments and "stealth modes"
- Capable of offering products of higher quality than those on the street
- It eliminates intermediaries of conventional drug supply chains



Market prices

1 ounce of marijuana - Average price: \$ 215.31 USD

1 gram of cocaine - Average price: \$ 97.39 USD

1 gram of MDMA - Average price: \$ 37.07 USD


- Monthly earnings: Deep web (\$12-21.1m); Europe Offline (\$2.3 billion)
- Web administrators receive 5-10%
- Only 1.8% of transactions in cryptomarkets are wholesale, but they generate 25% of the profits
- Few sellers operate in emerging economies, unlike the offline system
- The price is higher, but purity is also higher
- Price of Bitcoin

What works and what doesn't?

- Punitive approaches do not work on the internet, as in other contexts
- Markets can easily close (more nimble than the state)
- When you close a site, another site can be opened within days
- Traditional harm reduction experiences can be contextualized for the internet



Possible Benefits of the Deep Web

- A more trust-worthy way of buying substances that are not adulterated.
- Promotes more responsible use: Provide information about risk reduction.
- Reduce physical interactions that could lead to violence.



Harm Reduction


- More profitable than investing in repression
- Anonymous users can provide information on shopping experiences (Community Harm Reduction)
- Opportunity to interact with drug users
- Provide information on the quality, effects and risks of consumption
- Substance analysis programs
- The user can inform, compare and document himself
- Greater purity -> greater protection for users
